Q1. What is the proposed development and where is it located?

Q13. How do I book my home at Green County?

Ans : Booking can be done by submitting an application form along with a Demand Draft/ Cheque in favour of "ANAND DEVELOPERS ". We need the following at the time of booking

1. Booking Money draft /cheque @ 5% .
2. Buyers and Co Buyers details in the form duly filled and signed.
3. PAN No. & attested copy of PAN Card / Undertaking.
4. For Companies: Memorandum & Articles of Association and certified copy of Board Resolution.
5. For Foreign Nationals of Indian Origin: Passport Photocopy/funds from NRE/FCNR A/c.
6. For NRI/PIO: Copy of Passport Photocopy / Foreign inward remittance from the account of Alottee's /NRE/NRO A/c of Alottee's.
7. Signature on the payment schedule.
8. Signature on application for allotment.

Q14. What happens after I have done the booking?

Ans : Once your booking is done we will send you your allotment letter followed by intimation about Agreement for Sale. Further the company will also send you timely reminders on the payment due and it is also mentioned in the agreement.

Q15. Can I opt for a down payment option?

Ans : Yes. Please contact our sales team for the details.

Q16. How are installments to be paid and is it time bound?

Ans : By way of Cheque or Demand Draft payable at Pune drawn in favour of "ANAND Developers" And yes, the installments are time bound. It will be as per the payment schedule provided to you by us.

Q17. Can two flats be bought and combined into one flat?

Ans : Combination of flats is possible and also we have range of flat for you to choose from.

Q18. Are modifications permitted in the Flats?

Ans : Yes, limited modifications are permitted in the flat at an extra cost. Kindly check with us at the time of purchase for details. f5 Realtors follows a strict policy for any modifications and extra works, a list of pre requisite cost of modification of extra work is available with our sales team for your convenience.

Q19. What if my monthly EMI is delayed?

Ans : The company reserves the right to cancel the allotment in case of non-payment of the dues from the customer. However at its sole discretion, the company may choose to charge interest @ 18% on the delayed amount due from the client.

Q20. What happens if I cancel my booking?

Ans : Well, we would not encourage you to do it, but in an unforeseen circumstance should you choose to cancel, 5 % of the sales price will be retained by the company and the rest will be returned to you by way of cheque but only under the condition that the flat has not been registered.

Q21. Are transfer allowed? What is the process?

Ans : Transfer is allowed. The Applicant cannot transfer the registration, booking or allotment in favor of a third party for six months from the date of allotment of the flat by the Company unless approved by the Company, who may at its sole discretion permit the same on payment of transfer charges @ Rs.100 /sq.ft.

Q22. What are the types of Agreements to be signed by the Purchaser?

Ans : Post allotment the Sales Agreement has to be duly signed and registered between the purchaser(s) and ANAND DEVELOPERS, within 30 days of booking the flat.

Q23. Can I buy the property under joint name between me and my company?

Ans : Property can not be bought under your joint name and the company's name.

Q24. If a property owner's details change, how can they be updated?

Ans : Any change in details have to be given in writing to ANAND DEVELOPERS along with appropriate proof.

Q25. Can I know the process for NRI transaction?

Ans : For any Non Residential India (NRI) to book a place in Green County, they have to follow the same process of Application and Allotment as prescribed for Indian client. The transfer of money towards booking and other payments can be done through two modes:

1. Direct bank transfer between account to account via swift code.
2. Transfer of funds through an NRE / FCNR (B) / NRO account maintained in India to ANAND DEVELOPERS Bank account, if the client wishes to repatriate the money.

No payment can be made either by traveler's cheque or by foreign currency notes. No payment can be made outside India.
