## PROPOSED SELF FINANCING HOUSING SCHEME

### **Terms & Conditions for Registration and Allotment**

- 1. The intending Buyers has applied for the registration of Flats/Plots with full knowledge and subject to all laws, notifications and rules applicable to this area, which have been explained by the company and understood by him/her.
- 2. The intending buyers has fully satisfied himself/herself about the interest and title of the company in the land, understands all limitations and obligations in respect of it and does not have any objection.
- 3. The allotment of the flat/plot/villa/kothi by the company, against the registration of the applicant, shall be done within 9 months from the date of registration
- 4. The registration amount deposited by the applicant shall be adjusted at the time of allotment with the allotment money to be paid by the applicant/allottee(s)
- 5. For preferential situated flats/plots extra charges as applicable will be payable by the intending buyer.
- 6. The company shall pay a simple interest @7% p.a. over the deposited amount, if the company is not in position to allot the flat/plot/villa/kothi to the applicant within the specified period, except due to reasons force majeure.
- 7. In case of cancellation of the registration before allotment, the deposited amount only, without any interest will be returned to the applicant without any deduction within 60 days from the date of cancellation. However, in case of cancellation of the registration after the allotment of the Flat/Villa /Kothi /Plot, 25% of the deposited amount will be deducted and the balance amount will be returned to the applicant within 90 days from the date of cancellation.
- 8. Registration is for present/future projects where allotment would be made only after approval, permission and all clearances from related government/competent authorities.
- 9. The company shall have the right to effect suitable and necessary alterations in the plan/layout/Size/location. The area and measurements of Flat/Villas/Kothi/Plot may vary at the time of allotment (subject to approval of respective Govt. Authority) .The increase or decrease in the size will affect the cost accordingly.
- 10. The applicant will have to take the prior written permission to transfer his/her registration of Flat/Villa/Kothi/Plot, from the company and will have to pay the processing fees as decided by the company from time to time. At present on all subsequent transfer after the first transfer the company will charge transfer and/or processing fee @ 2% of total cost.
- 11. All payments towards the cost of Flat/Villa/Kothi/Plot shall be made in favour of only SHAURYA HOUSING LTD. through Cheque/D.D payable at New Delhi.
- 12. The company reserves its right to cancel the registration/allotment if the future payments are delayed by two months.
- 13. Allottee would be liable to bear all taxes/levis/charges, as applicable for the time being and in future if any.
- 14. Delhi court alone shall have jurisdiction in all matters concerning this transaction.
