Lightening protection & Earthing pits: Lightening pits provided for base building. Provision for tenant connection to Earthing pits.

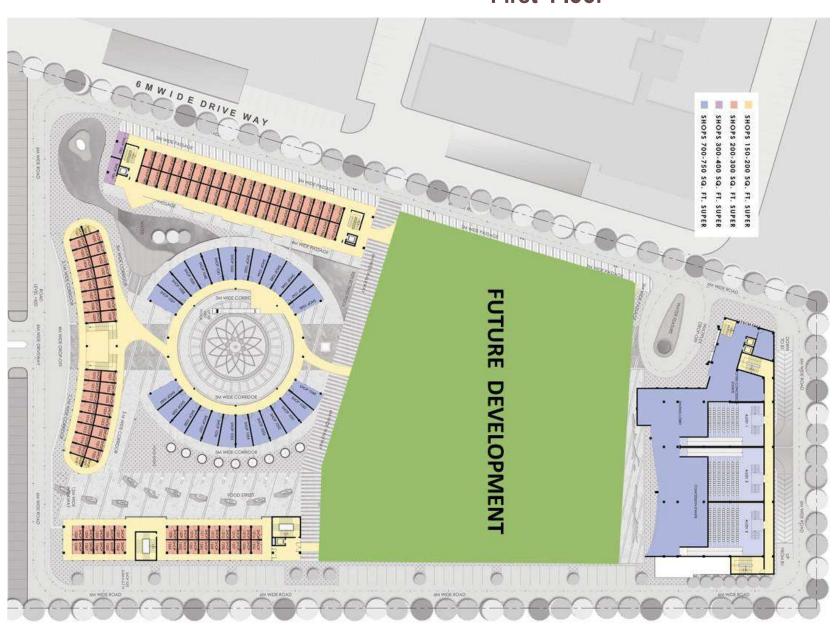

Emergency Lighting: Emergency light fixtures (connected to landlord's UPS) provided on escape route and at all means of egress.

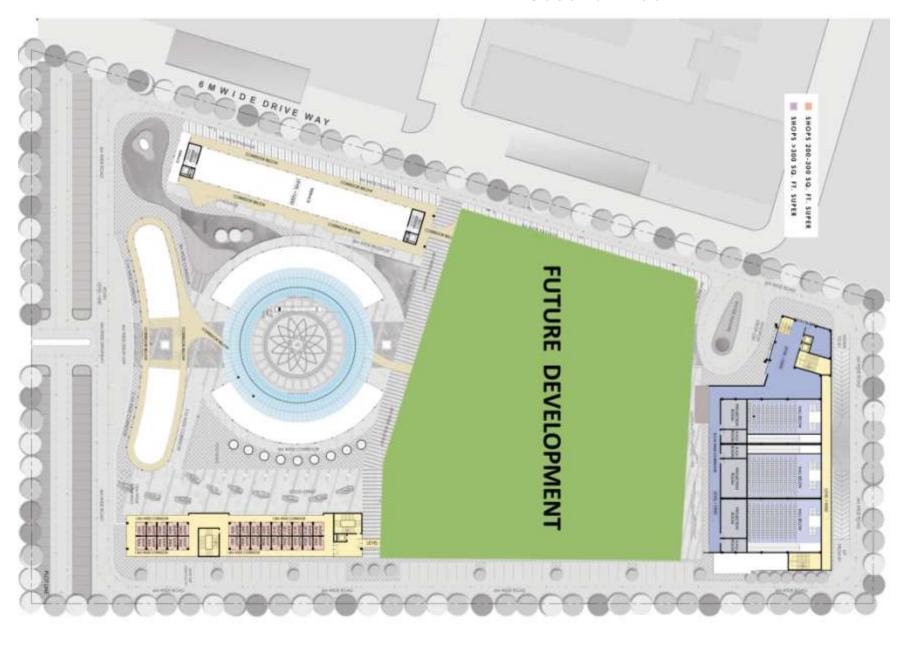
