- All other charges for Mantra Meadows like EDC (External Development Charges) & IDC (Internal Development Charges) @ ₹ 185/- per sq. ft. and EEC (External Electrification Charges) & FFC (Fire Fighting Charges) @ ₹ 50/- per sq. ft. as applicable.
- Power Back-up Installation Charges @ ₹ 20,000/- per KVA payable as applicable, minimum 2 KVA is mandatory for 2BHK & minimum 3KVA for 3BHK.
- One time IFMS as applicable intimated by the company shall be payable at the time of possession.
- Registration, Stamp Duty, Service Tax, Statutory taxes and other Government Levies / Concern Authorities charges shall be payable extra by customer on offer of possession.
- If the Company fails to offer possession of the flat within the stipulated period, subject to reasonable delay of 180 days then the Company may pay to Allottee compensation up to a maximum of ₹ 5/- per sq. ft. of the area of the flat per month. Further if Allottee(s) fails to take possession of apartment within "Fit Out Period" the penalty shall be charged @ ₹ 100/- per day for delayed first month and @ ₹ 200/- per day for delayed second month from the date of expiry of " Fit out Period" thereafter the booking/allotment of apartment shall be treated as cancelled without any further notice, and the amount received shall be refunded without any interest, after forfeiting amount equivalent to the 5% of the cost of apartment as per company's terms and conditions.

- Timely Payment of Installments and other charges is essence of the Agreement.
