

GENERAL SPECIFICATIONS

1. STRUCTURE

- RCC framed structure and AAC blocks/solid block used for external/internal walls.
- · Earthquake resistant structure.
- Anti-Termite Treatments wherever applicable during construction stage.

2. TILING

2.1 FLOORING

- · Living, Dining, Kitchen and Bedrooms & family-2'x2' premium vitrified tiles.
- Master Bedroom will have wood colored vitrified tiles.
- · Toilets, Balconies & Utility Area-Anti-skid ceramic tiles.
- Staircase-18mm granite/ Marble.
- Car park-paver blocks

2.2 DADO

- Kitchen-2 feet ceramic tile above the counter.
- · Toilet-glazed ceramic wall tiles upto 6 feet height from the floor level.

3. KITCHEN

- Stainless steel sinks with drain board of brand Deepali or equivalent make
- · 18mm black granite for kitchen counter

4. DOORS / WINDOWS /VENTILATORS

- Maindoor-7 feet height, with a frame made of good quality sal wood.
 35 mm thick teak door and designer hard ware of GODREJ or equivalent make.
- Bedroom door 7 feet height, with a frame made of good quality sal wood.
 Skin molded paneled door.shutter of 32 mm thickness and designer hardware's of GODREJ or equivalent make.
- Toilet door- 7 feet height, with a frame made of good quality fiber. Fiber door. Shutter of 30 mm thickness. Designer hardware's of GODREJ or equivalent make.
- Coated Aluminum windows with sliding shutters for all windows will be provided.
- · Mosquito net wherever applicable.

5. PAINTING FINISHES

- All internal walls will be coated with smooth putty, primer with 2 coats of tractor emulsion paint of Asian/Dulux or equivalent make.
- All external walls will be finished with 2 coats of weather proof exterior emulsion paint as per the architect's design, of Asian / Dulux or equivalent make.
- Ceilings will be finished with smooth putty, primer and 2 coats of tractor
 emulsion
- · Stair case railing as per the architect's design will be provided.
- MS railing for balcony finished with enamel paint aesthetically designed
 fixed to wall as per the architect's design.

6.ELECTRICAL FIXTURES /FITTINGS


- · Three-phase power supply with concealed wiring will be provided.
- · All switches will be of ANCHOR or equivalent make.
- Cables & wiring will be of ANCHOR / FINOLEX / POLY CAB or equivalent make.
- Split A/C provision with electrification will be provided in Living Room and all Bedrooms.
- Geyser provision with electrification will be provided in all Toilets.
- · Power backup for 1KW in villas & minimum essential points.
- · 100% power backup for common area.

7 TV AND TELEPHONE CABLE

 Concealed TV and Telephone points will be provided in the Living and in all the bedrooms.

8 PLUMBING & SANITARY

- All sanitary ware in ceramic of brands like Hindware / Parryware or equivalent will be provided.
- EWC (European Water Closet) with a health faucet, of brands like Hindware / Parryware or equivalent, will be provided.
- All plumbing CP fittings, of superior brands like Hindware / Parryware or equivalent, will be provided.
- Single lever HI-FLOW concealed diverter, of Hindware / Parryware makes, of hot & cold mixer with overhead shower, will be provided in the toilets.
- CPVC pipelines / UPVC soil waste lines / sewage pipelines & rainwater lines, of superior brands like ASTRAL / SUPREME / PRINCE or equivalent ISI certified brands, will be provided.
