RERA CARPET AREA - 1184 sq. ft.




TOWER - 2



RERA CARPET AREA - 1184 sq. ft.




TOWER - 2



BALCONY 6'-0" WIDE


TOWER - 4



BALCONY 8'-0" WIDE


TOWER - 4
